This is a true and correct copy of the minutes of the Regular City Council Meeting for the City of Wallis, Texas held on Wednesday, April 21, 2021 at 6:00pm.

1. Call to Order - Mayor Diggs called the meeting to order at 6:00pm.
2. Invocation and Pledge of Allegiance – Led by Councilmember Clark Main Jr.
3. Roll Call – A quorum was present, Councilmembers present were Councilmember Felix Galvan Jr., Councilmember Clark Main Jr., Councilmember Bernadette Parr and Councilmember Daniel Martinez. Councilmember James King was absent. Also present, Mayor Diggs.
4. Communication from the Public – None
5. Consent Agenda – Motion made by Councilmember Clark Main Jr., second by Councilmember Daniel Martinez to approve the minutes from March 17th, March 24th and April 5th meetings. Motion passed unanimously.

7. Financial Review and payment of bills – Motion made by Councilmember Clark Main Jr., second by Councilmember Daniel Martinez to approve the financial report and payment of bills. Motion passed unanimously.

d. Ordinance No. 236 – Motion made by Councilmember Clark Main Jr., second by Councilmember Felix Galvan Jr. to accept and approve Ordinance 236; annexation of the Mynarik Park and City Barn Properties. Motion passed unanimously.

e. Preliminary Plat Plans – Motion made by Councilmember Clark Main Jr., second by Daniel Martinez to approve Preliminary Plat Plans for Sunset Estates. Motion passed unanimously.

f. Playground Equipment – Motion made by Councilmember Daniel Martinez, second by Councilmember Felix Galvan to approve bid for Full Basketball Court and Volley Ball Court from Athletic Design Group, purchasing bench seating around the courts. Motion passed unanimously.

Motion made by Councilmember Daniel Martinez, second by Councilmember Felix Galvan Jr. to approve bid for Playground equipment from Adventure Playground Systems, Soccer Goals from Adventure or McKenna, whichever one has best pricing. Motion passed unanimously.

Motion made by Councilmember Daniel Martinez, second by Councilmember Felix Galvan Jr. to approve bid for Dog Park from Adventure Playground Systems, with Chief Moseley getting bids for fencing around dog park. Motion passed unanimously.

Health Permit forms for the food trucks – Motion made by Councilmember Bernadette Parr, second by Councilmember Clark Main Jr. to approve the Mobile Food Truck Establishment Health Permit forms for the Food Trucks. Vote was 3 yes, 1 no, Councilmember Bernadette Parr, Councilmember Clark Main Jr. and Councilmember Daniel Martinez voted yes and Councilmember Felix Galvan Jr. voted no. Motion passed 3 yes votes.

c. Interim Food Truck Court Occupancy Agreement – Motion made by Councilmember Clark Main Jr., second by Councilmember Bernadette Parr to approve the interim food truck court occupancy

agreement. Vote was tied, Councilmember Bernadette Parr and Councilmember Clark Main Jr. votes yes and Councilmember Daniel Martinez and Councilmember Felix Galvan Jr. voted no. Mayor Diggs broke the tie by voting yes. Motion passed with 3 yes votes.
